

## How to Get Started in...

### Autocrossing (a.k.a. Solo)

Bill Loring

How long have you been autocrossing and how did you hear about SCCA to get started?

I started autocrossing in 1989, I think. I know that I won my first 1st place trophy on November 5th, 1989 at a South Bend Region event at Elkhart Memorial HS. I was so proud of that moment, that I recorded this fact on the back of the trophy that I still have in a box in the basement. My car was an E-Stock 1984 Honda Civic 1500s. I spent my first season running on stock Michelin tires that had 80,000 miles on them. In time, I upgraded the car with Yokohama, then BFGoodrich race tires, Tokiko Adjustable shocks, a Jackson Racing muffler, and a 4-point harness. I got started in autocross because of my father, Lloyd Loring. Growing up, we often went to SCCA races, where he would act as a race worker and announcer. I remember going to the June Sprints, and seeing races at Blackhawk Farms. I have fond memories of riding home in the car, still being able to hear the sound of revving race engines in my head. When I was living in Bloomington, IN., I began talking to my dad about the solo events that he attended on a regular basis. I really hadn't paid much attention as a kid to what he was doing, but now that I had a car of my own that handled pretty well, it started to sound interesting. It really wasn't until I started running events that I realized what a popular and beloved figure he was in the CENDIV SCCA community. Living in Bloomington, I attended events in South Bend, Indianapolis, Columbus, Louisville, Evansville, Cincinnati, and more. There was nothing very close, but nothing was really far away, either.

### You've been running the stock classes for most of your career, why have you chosen this path as opposed to prepared or formula classes?

Stock class has always been the most convenient for me, and while I feel that I have an aptitude for working on cars, I'm not that excited about spending a lot of time actually doing it. Perhaps if I could get the car into the basement... I spent one season co-driving with Ricardo Gonzales, in an F-Modified Solo Vee (which Autocross Cont'd on p.4

#### Road Racing

Joe Woodward

How long have you been road racing and how did you hear about SCCA to get started?

I have been in the SCCA for around 15 years. I came from a family of race fans. I grew up going to the Indy 500, Saturday night circle tracks and also had a brother that raced a Fiat 600 for a while in the SCCA. Sports cars were in our family and still are. MG's, Triumphs and Fiats. My interest has been in road racing growing up, but I could not find the time or resources to get started. I had a Miata that I drive on the street and fell in love with the car. When the SCCA announced the Spec Miata series, I kept on watching it with interest. The next year I came across a 1990 Miata with 130k miles, rust, ripped soft top, hail damage and other issues. It said "Spec Miata" all over it! After asking the price (too much) I walked out, came back 45 minutes later with a low ball offer. Walked out with my 2nd Miata. I spent much of that spring and summer building the car. The first race I went to was at Mid Ohio. 8 Spec Miata's there. 100 degrees out. A new car and a rookie driver. Managed a 6th place finish in class. That was the summer of 2002.

#### You recently won the CENDIV Regional series in Spec Miata, was it all driving, car prep, luck, or a little of all three?

It was a little bit of all 3. I have learned to drive the car a bit better as time goes on. My crew chief, Bruce Woodward, helps with the car prep. That leaves me more time to concentrate on other things (screwing off). The cars are pretty "bullet proof" and requires minimum maintenance, but we do take the time to do the basics and it shows. We have not had a mechanical related DNF in 3 years. Luck was also riding with us last year and we were happy to have it.

#### Do you like the direction Spec Miata is heading?

I have not been keeping watch during the off-season and following the politics too much during the off-season. I understand that they are opening up the pro series to 2nd generation Miata's and will probably open up the national and regional series to 2nd generation *SM Cont'd on p.5* 



### East vs. West

#### The Splitting of CEN.....DIV

Good day! The Racing Season is about to start. Our first National event is about 60 days away. It is time to get ready.

**Division Split**– Well, now that I have your attention, let us discuss the obvious. Cendiv will be split sometime in the near future. The Directors, (Mike Engelke and Erik Skirmants) and I have discussed this with a plan to develop the infrastructure to allow both entities to prosper. While Mike and Erik can answer specific questions and the timetable, the 2006 racing schedule is being planned for Cendiv as it is currently constituted.

**Scheduling** – We have a scheduling process in Cendiv that should work better than it does. If we plan now, we can avoid some of the past problems. Please familiarize yourself with GCR section 3, especially section 3.17. This spells out the procedure for National races, but does not address Regional racing. We have always conducted Regional scheduling the same way. The fact is we schedule at the convenience of the tracks with dates that have been traditionally ours, but never guaranteed. Liz Lowy has done a masterful job of coordinating all the pieces into a cohesive schedule. To help Liz and to be fair to all regions, the schedule that is approved at Roundtable is the schedule. There will be no changes once you all approve it unless for some reason, the track dictates a change.

With that in mind, even though we have not started the 2005 schedule, we should be thinking of the 2006 schedule. We have new tracks emerging in Area 5 at Autobahn (Joliet, IL) and Milwaukee. We want to expand our racing at GingerMan and we would like to have a National race at Nelson Ledges. We are generally committed to a 10 race National schedule in 2006, but this may be flexible with proper cause.

I personally would like to see Regions that are not currently "racing regions" become part of the process and join with one of the "racing regions" to co-sponsor an event. Even a 1/8 fractional ownership gets more of our members involved with our programs. At the same time, some of the

regions are running major events without enough participation from the sponsoring region. Get your members to support your program. We will be establishing guidelines for this later in the season.

I mention the above now to stimulate your thinking about **race dates**, co-sponsored events, and conforming to the established policies of Cendiv and the GCR. The Japanese have a term, "nemawashe." It means we agree to agree before we agree. It is our goal to go to Roundtable this year with a well thought out, fair schedule that we can all accept.

Roundtable – Roundtable will be hosted by Milwaukee Region this year (thanks Julie). And thank you to all the other regions who volunteered to host. It has been some time since we held this meeting in Area 5. Yeah, I know, I have to drive around Chicago too. The good news is that we will finish the meeting by 5:00 PM Saturday, so the drive home should be no problem.

BTW – this is **your meeting**. By that I mean the RE's meeting. Somehow, over the years, Roundtable became organized and planned by the Executive Steward. I officially turn this back over to you. I need time for the Scheduling Meeting, but the rest of the agenda is yours. Enjoy.

Racing Sanctions, SUPPS and Entries. Our Deputy Executive Stewards and I remind you about the process for sanction. We have already sent out Steward Sign-ups for your races. We have 94% returns to date. These lists are being forwarded to your respective Chief Steward and Race Chairperson (where identified) for their final assignment and approval. When you have your SUPPS and Entry finalized, please send them to the appropriate Deputy

Cendiv Treasury - So you know, Cendiv has operating funds accumulated by various fees. When I first was introduced to this job, my initial thoughts were that the balance we kept (a bit over \$50,000) was beyond our needs and I was looking for ways to reduce the balance for the good of the division. After meeting with my counterparts at the National Convention, I now believe our balance is correct for our needs and any contingencies that may develop. When we split the division, it will be important to have adequate funding for both entities. So we will continue to be fiscally conservative in our approach to disbursements.

Also, you should know that any disbursement requires both my signature and that of our Treasurer, Bev Heilicher. Since neither of us need the money or the jail time, your funds are safe.

now belongs to Greg Powers), and another season in Jeff Harrison's DSP Dodge Neon (which is for sale, I think). Both seasons were huge fun, and I would have loved to have continued driving either car, as at the end of the season, I was just beginning to feel like I was getting the hang of each car. But as fun as they were, I just can't justify the extra garage space, the tow vehicle, and the expense.

2004 was your first year attending the Solo Nationals in Topeka, how did it go? Anything go particularly well? Anything unexpected? If you were to go again, what would you do differently?

Actually, this was my third Nationals, but my first time to win a trophy. I went in 1999 with Ricardo, and finished one spot out of the trophies. I went again in 2001. This fell just days after the events of Sept. 11, and was a whole story in and of itself. Once again, I was one spot out of the trophies. In 2004, everything seemed to come together. I had a new car, a 2000 Toyota Celica GT,

which was actually considered to be one of "the" cars for the class. It was well-prepared, and I felt like I was driving fairly well. Everything went pretty much as expected this year, although the rain on day two kept the whole class guessing about what tires to use. I ended up getting 8th, out of 41 drivers. I was happy, but I'd still like to do better.

#### What will you change for next year?

I'm not sure. The SCCA has announced that the 2005 MINI Cooper S will be in GS. The '05 MINI gets an optional Limited Slip Differential, which will make the car much stronger out of the corners. There are many who feel that this car will walk away with the class. I had originally planned to put some money into new shocks and lightweight wheels. Those plans are now on hold while I find out how my car will do against the new MINI. In the meantime, I need to work on the driving... I have always felt like I am not as consistent a driver as I'd like to be. I think improving my mental focus will help that.

#### Bill's Tips for Autocrossers

- 1) Have fun! Fun is what the sport is all about.
- 2) Spend more time thinking about what you can do to improve your driving, than worrying about your car setup.
- 3) Find someone to learn from. Taking rides in someone else's car, and let them ride with you. This can be one of the greatest ways to learn. Even seasoned autocrossers can learn from this.
- 4) Volunteer to help. You're probably more likely to get friendly advice and offers for ride-alongs and course walks if you're helping make the event happen.
- 5) Look ahead. As far ahead as you think you are already looking, it's probably still not far enough. If you're not using the side windows, you need more practice looking ahead. I've found that mountain biking on tight, technical trails is great practice.

cars in the future. We do receive excellent support from Mazda and I am sure that they would prefer to see the newer cars in the class instead of the just the older 1st generation cars there. If the price to keep Mazda's support in the class is having the newer cars in, I am in favor of it. Tire rules appear to be opening up. A number of competitors would prefer to have a single or two tire rule. I do see that for a regional class or perhaps a separate class. Personally I do prefer the open tire rule. I am probably one of the few people that came out ahead on my tire budget this year. Yes, I made more in contingency money than what I spent. Open tire rules do keep the cost down between brands and increased manufacture support with contingency funds.


#### What are some typical expenses associated with running spec miata?

The Spec Miata is one of the least expensive cars that you can run. After the car is built, the largest mechanical expenses would be tires and brakes. Other large expenses would be travel related and registration for the events.

#### Joe's Tips for Spec Miata Racers

- 1) Visit the SpecMiata Website www.specmiata.com
- Go to some races and "hook up" with a SpecMiata driver. Most of the competitiors in this class are very friendly and willing to help new drivers.
- 3) Get as much track time as possible even if you can't afford all of the "bells and whistles" for car prep.
- 4) Take the time to do prevenative maintenance. There is nothing more frustrating than getting to the track and fixing something that you don't have parts for.
- 5) Remember that you are driving a car where momentum through the corners is what wins races.
- 6) Enjoy the people and the racing. There is no sense in trying to push a guy off of the track in order to get by him. Sitting around and bench racing is a whole lot better than trying to pound out a fender.
